ORDER

Sub: Grant of Dearness Allowance to State Government employees.

The Governor is pleased to order that the existing rate of Dearness Allowance payable to the State Government employees, drawing pay in the Rajasthan Civil Services (Revised Pay) Rules, 2017, under Finance Department Order of even number dated 31-10-2023 shall be revised from 46% to 50% with effect from 01-01-2024.

2. The term 'Pay' for the purpose of calculation of Dearness Allowance shall be the Basic Pay i.e. pay drawn in the Pay Matrix of the prescribed Levels and shall not include any other type(s) of pay like Special Pay or Personal Pay etc.
3. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.
4. The amount of increase in Dearness Allowance for the period from 01-01-2024 to 29-02-2024 shall be credited to the GPF Account as per provisions of Rajasthan Government Servants General Provident Fund Rules, 2021 as under :
 - (i) For the employees recruited before 1-1-2004 - GPF Account.
 - (ii) For the employees who were recruited on or after 1-1-2004 - GPF-2004.
 - (iii) For the employees of Autonomous Bodies / PSUs / Boards / Corporations etc. - GPF-SAB.
5. Cash payment shall be admissible from 01-03-2024 i.e. salary for the month of March, 2024 payable on 01-04-2024.
